You will need to get a notary to witness your signatures; the notary will stamp his/her seal into the bottom left corner of this document and sign accordingly.

The section at the bottom beginning the words "Subscribed and sworn to by each . . . and ending in Filed this \_\_\_\_\_ of \_\_\_\_\_" will be completed when you are actually at the Territorial Court/Superior Court here on-island at that time.

If either party is divorced, an original certified copy of the divorce decree must be sent with the Application for Marriage License.
